

Delivery terms and conditions Immobilisation at Mineralz Maasvlakte (IMMO)

The following supplementary terms and conditions apply to the delivery of waste products brought to the IMMO plant for immobilisation, in accordance with the associated agreement.

GENERAL:

- These delivery terms and conditions for IMMO are part of the General Terms and Conditions for Mineralz Maasvlakte;
- By handing in a signed consignment note for waste upon delivery, the intermediary/disposer declares that he/she agrees with the
 rates and present terms and conditions set by Mineralz Maasvlakte as well as with the General Terms and Conditions for
 Mineralz b v.

ACCEPTANCE:

- All coarse objects must have been removed from the waste such as metal, plastic, wood and so forth;
- The maximum grain size of the waste is 40 mm,
- If irregularities are found, Mineralz Maasvlakte will inform the disposer directly. Any costs arising from this will be charged to the disposer:
- If <u>after</u> the batch has been treated, it is evident that it has caused damage to the plant, all repair costs and any delays caused to third parties will be charged to the disposer;
- If the batch supplied deviates from the physical and chemical characteristics of the waste stream stated by the disposer beforehand, any costs arising from that will be charged to the disposer;
- If waste (sludge and filter cakes) is delivered on containers/trailers, these must be adequately protected from rainfall entering. If
 any free water is detected on top of the waste, through which unloading and treatment are no longer deemed possible, we will be
 forced to send the load back.

Waste with the following properties will not be accepted:

- waste that is susceptible to self-combustion, is explosive, or could undergo exothermic reactions with air, water or other waste products, or that could develop combustible or poisonous gases;
- waste that is not solid ("cannot be formed");
- waste that gives off a strong-smelling odour;
- waste that could damage the plant equipment;
- waste that is or contains meat, fish or pathological matter;
- waste that exceeds the applicable limits for radioactive materials (requires authorisation);
- waste that falls within one of the categories implemented by the "Besluit stortplaatsen en stortverboden afvalstoffen" (BSSA Decree on landfills and waste prohibited from landfill), other than exceptions made by a competent authority;
- waste that contains more than 10% of digestible organic material.

OPENING TIMES:

- The IMMO is open on workdays from 07:00 am to 6:00 pm;
- The IMMO is closed on national holidays;
- The IMMO is closed temporarily (for safety reasons) when there are wind speeds of 7 bft (32 mph and above).

VEHICLES:

- Drivers must be able to speak Dutch, German or English to A1 level, basic language skills;
- Unloading dry (waste) materials using a double or intermediate coupling is not permitted. Bulk trailers with this type of coupling will be refused;
- The air supply to the discharge (elbow) pipe must be fitted with a non-return valve which must be securely mounted on the discharge (elbow) pipe. Bulk trailers with an intermediate coupling will be refused;
- For the connector, the hoses must have a 4" Storz coupling with a cam distance of 133 mm. In case of disasters, the bulk trailer must have a vent cock fitted with a 2" Storz coupling with a cam distance of 66 mm;
- Using your 'own' outlet hose is not permitted. Mineralz Maasvlakte will always provide an outlet hose;
- Connecting and disconnecting will only be conducted by the Driver. The operator on duty will fit the safety clamp safety device
 and remove it once the bulk trailer is at atmospheric pressure;
- Bulk trailers must use the outrigger plates available at the location;
- Only vehicles where the container/trailer can be opened safely and the waste can be unloaded safely are allowed;
- Tipper trailers are not allowed due to height restrictions; this is related to the safety of both your own employees as well as ours.

SUPPLY:

- Every delivery must have a consignment note for waste and a cover letter for each waste stream number;
- On the Mineralz Maasvlakte site, the Mineralz Maasvlakte Safety Rules for Truck Drivers apply;
- Big bags must be delivered on wooden robust and undamaged pallets;
- Big bags must not have an inner liner;
- Big bags must not be stacked;
- Big bags may not weigh more than 1100 kg each;
- big bags must be delivered clean, dry and undamaged.

PLANNING:

- To schedule the treatment, please contact Mineralz Maasvlakte;
 - The IMMO would like to receive your request no later than Thursday the week before;
 - Register by email at immo.maasvlakte@mineralz.com, stating the waste stream number; Deliveries can only be made if you have received confirmation;
 - - For delivery by container or big bag, delivery before 14:00 applies;
 - For delivery by bulk silo truck, delivery at the specified time applies;
